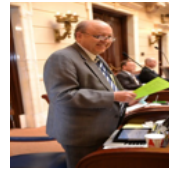

Senator Lyle Hillyard (R), an attorney, represents the Utah 25th Senate District. He served as the Executive Appropriations Chair from 2009-2016. In 2017, he was appointed Chair of the Educations Appropriations Committee. He and his wife Alice have five children.

Representative Dan McCay, an attorney and real estate developer has served in the Legislature since 2012. He also earned an education degree at Utah State University He has been chair of House Revenue and Taxation and currently serves as co-chair of the Education Appropriations Committee. He and his wife Tawnee have six children.



Ron Jibson is the former Chairman of the Board for Questar Corporation. Upon completion of the merger with Dominion Resources, Mr. Jibson retired. He served as chairman of the Board from 2012-2016. Prior to that, he was an executive vice-president, and president of its utility subsidiary, Questar Gas Company. He has held several Questar executive and management positions since starting with the company in 1980. He was a member of the Board of Trustees for Utah State University and served as chair of that governing board.

Bob Marquardt is the president and CEO of Management & Training Corporation and has been a member of the senior management of that firm since 1991. Previously, he served as vice president of marketing and president of Meridian Publishing, a subsidiary of MTC. His public service experience includes membership on several boards and organizations, including the Board of Trustees of Weber State University and currently as a member of the Utah Board of Regents.



Keith M. Buswell, Vice-President for Corporate Relations for the Wadman Corporation, a commercial construction company. They have built resorts, offices, warehouses, Walmart and Smith's buildings, as well as religious buildings including the LDS temple in Payson, Utah.
