Governor Gary Herbert

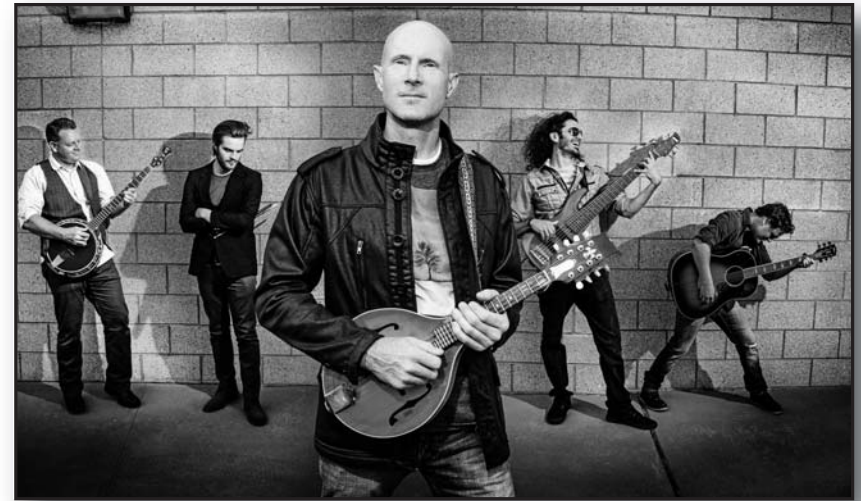
Featured Speaker

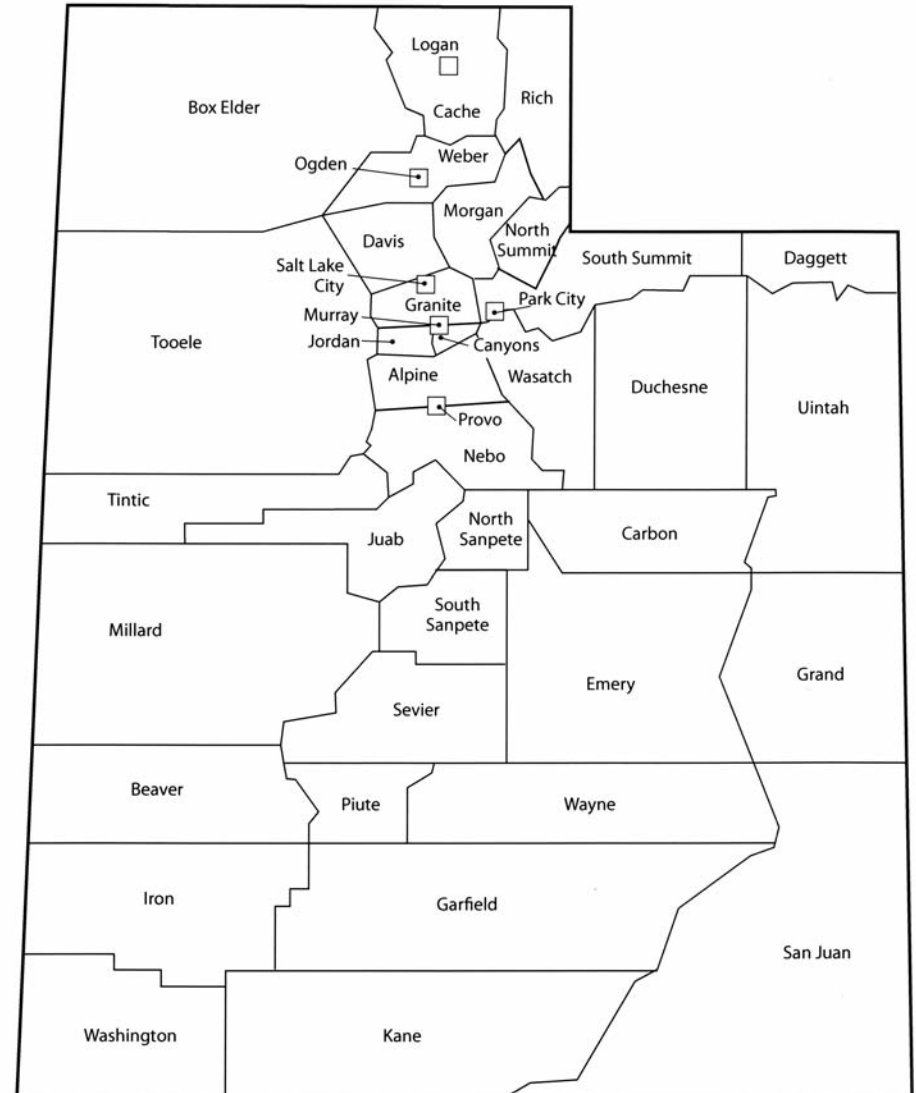

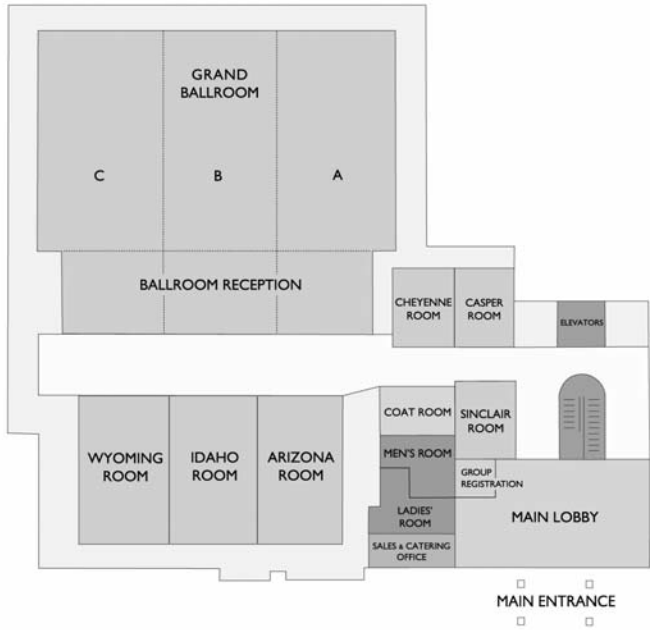
Utah School Districts Map



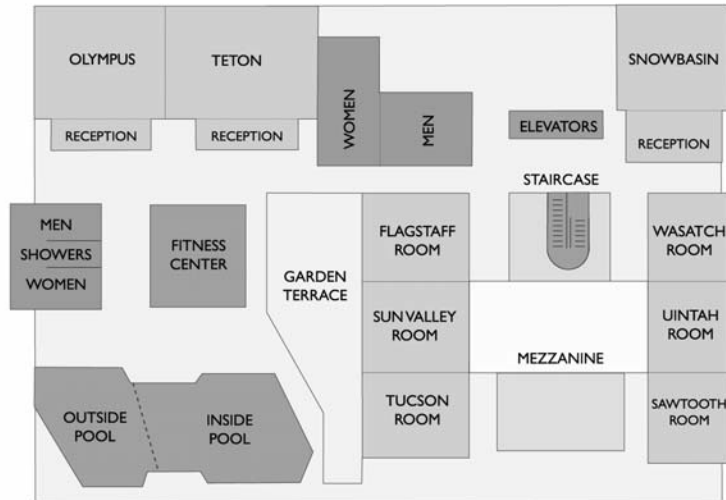
Little America Hotel Floor Plan Map
