The 'Lake Mountain' School District Board of Education, Saratoga Springs, Utah is seeking qualified candidates for the position of Superintendent of Schools. The person selected will be the first superintendent in this new district created when voters in the communities of Cedar Fort, Eagle Mountain, Fairfield, and Saratoga Springs voted to create their own district.

Anticipated start date: On or before July 1, 2026.

Salary and Benefits:

The compensation package will be competitive for the size of the school district in Utah and will be determined by professional preparation and successful experience in educational administration, as well as other pertinent qualifications. In compliance with Utah law, superintendents receive two-year contracts.

Basic Requirements:

- 1. Applicants must have or be qualified to obtain a Utah administrative license.
- 2. A master's degree is required. Additional education or experience preferred.

A successful record of administrative experience and accomplishments required.

3. Applicants must have demonstrable experience as a leader of a sizable organization. Leadership experience in a K-12 school system is preferred.

Requirements: A complete application consists of:

- A formal letter indicating your desire to be considered as a candidate for the position of Superintendent of Schools of 'Lake Mountain' School District.
- 2. A completed superintendent application form.
- 3. A complete set of current credentials, administrative qualifications, and transcripts from universities where you earned your degrees.
- 4. Three professional letters of recommendation.
- Current résumé including accomplishments as an administrator and a statement of your educational philosophy, how you have successfully used data in the past and what your focus would be for the district.
