

## **EHE—Graduation: Adult Education Graduation**

*[Utah State Office of Education regulations specify that adult education students may not be required to attempt or pass the UBSCT to qualify for an adult education diploma. The regulations permit Districts to determine (1) whether adult education students may elect to take the UBSCT, (2) whether adult education diplomas reference the adult student's participation in UBSCT, and (3) whether adult education students may participate in graduation ceremonies and activities. The options set out in this model policy reflect the different choices that a district may take regarding adult education (Options 1, 2, and 3 relating to UBSCT participation and noting such participation on diplomas, and Options A and B relating to participation in graduation activities).]*

[Option 1]

### **Adult Education Diplomas**

The District will award an Adult Education Diploma to each adult education student who successfully completes the requirements established by the District within the time requirements for that completion.

### **Adult Education Student Participation in UBSCT**

Adult education students are not permitted to take the Utah Basic Skills Competency Test (UBSCT), and the requirements for an adult education diploma do not include attempting or successfully passing the UBSCT.

### **Adult Education Diplomas**

The District will award an Adult Education Diploma to each adult education student who successfully completes the requirements established by the District within the time requirements for that completion. Those requirements do not include taking or passing the Utah Basic Skills Competency Test (UBSCT), and the Adult Education Diploma does not distinguish between students who pass the UBSCT and students who do not take or do not pass the UBSCT.

### **Adult Education Student Participation in UBSCT**

Adult education students may choose to take the UBSCT during their enrollment as adult education students in the District if they are at the adult education levels which correspond with tenth, eleventh, or twelfth grade. Adult education students are not

required to either attempt or to pass the UBSCT in order to obtain an adult education diploma.

**Adult Education Diplomas**

The District will award an Adult Education Diploma to each adult education student who successfully completes the requirements established by the District within the time requirements for that completion. If the adult education student chooses to take the Utah Basic Skills Competency Test (UBSCT) through the District and successfully passes all subtests of that test, the diploma awarded to that student shall be designated “Adult Education Diploma (Passing All Subtests of UBSCT)”. If the adult education student completes all adult education requirements and chooses to take the UBSCT but does not succeed in obtaining a passing score on all subtests, the diploma awarded to that student shall be designated “Adult Education Diploma.”

**Adult Education Student Participation in UBSCT**

Adult education students may choose to take the UBSCT during their enrollment as adult education students in the District if they are at the adult education levels which correspond with tenth, eleventh, or twelfth grade. **Adult Education Student Participation in Graduation Ceremonies**

Adult education students do not participate in graduation activities and ceremonies for high school students in the District. The District may conduct separate graduation activities and ceremonies for adult education students.

**Adult Education Student Participation in Graduation Ceremonies**

Adult education students who have successfully completed the requirements for an adult education diploma since the last high school graduation ceremony for the high school in

the attendance area where the adult education student resides may participate in the graduation activities and ceremonies for that high school.
