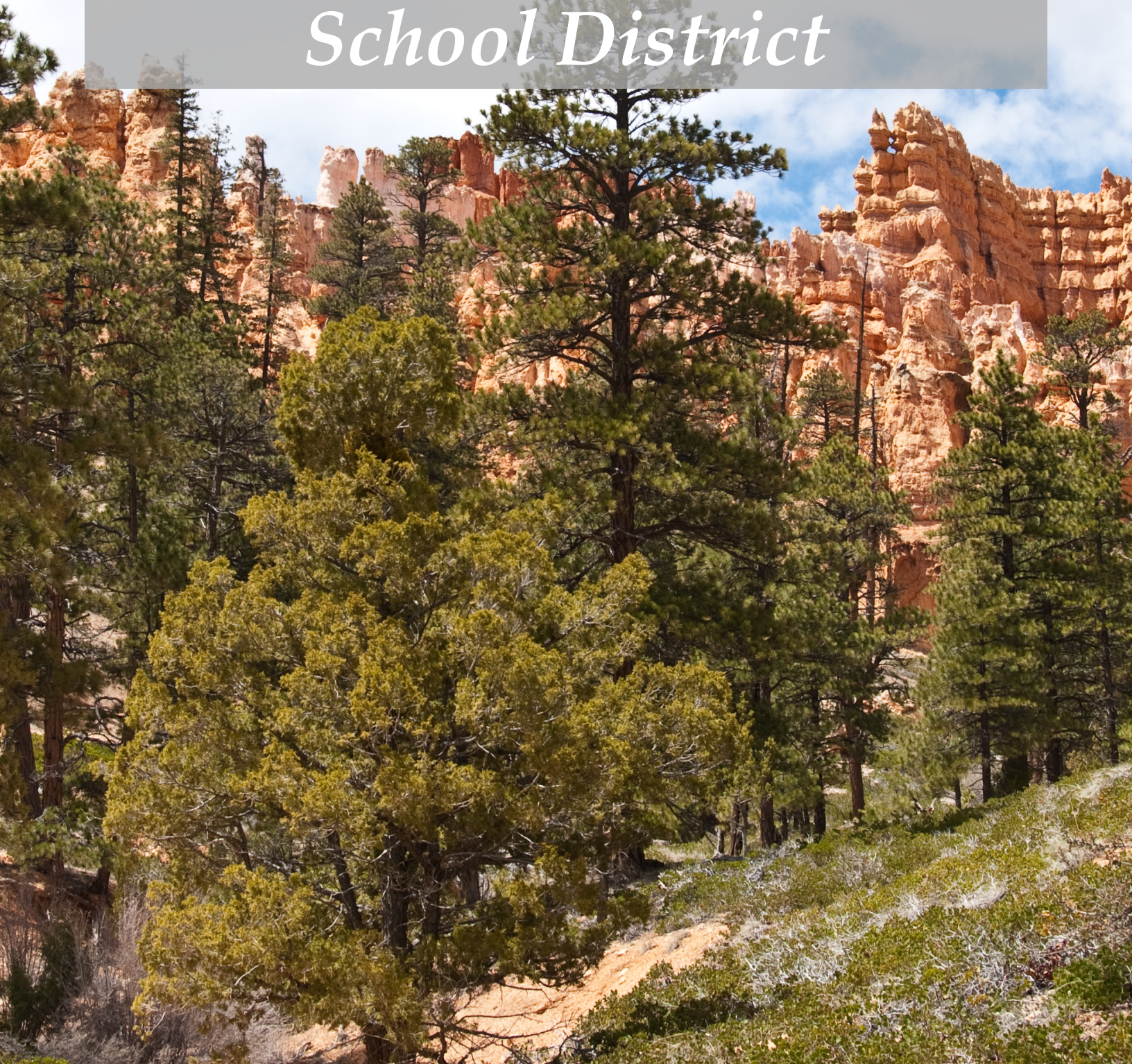

District Information

Garfield County School District is home to the most scenic county in the world. It serves 901 students spread across 5,200 square miles. There are five elementary schools, one middle school, and three high schools.

The district has an annual operating budget of approximately \$10 million. Revenue sources are 64% state, 32% local, and 4% federal. The district is in the process of constructing new elementary schools and has no General Obligation debt.
