## **District Dem**




Davis School District is a Pre-K-12 public school district with boundaries contiguous with Davis County, Utah, just north of Salt Lake City.

The district operates 92 schools, which consists of 62 elementary schools, 17 junior high schools, nine high schools, three alternative schools and an online school.




The district's mission is Learning First. Its 10 high schools boast a graduation rate of 94.2 percent, the top rate among school districts along the Wasatch Front.

Students earned more than \$63 million in scholarships in 2021. The District is one of only two in the state to achieve accreditations for all of its schools.

Nearly 6,750 full-time equivalent employees work for the Davis School District. The district is the second-largest employer in Davis County behind Hill Air Force Base.

A nearly \$860 million budget operates its 92 schools. Additionally, residents have supported voter-approved bonds in 2015, 2009, 2006 and 2002 to build for continuous growth.



The district is home to 16 Title I schools and 12 language immersion schools.

More than half of the state's 16 STEM-designated Platinum schools are in Davis School District boundaries. Additionally, two schools boast a Microsoft Showcase School designation and two are Apple Distinguished Schools.
