

The current membership in the Utah School Superintendents Association includes 41 school districts, the Utah Schools for the Deaf and Blind (USDB), the Utah State Office of Education (USBE), and four Regional Education Service Agencies (RESA) serving rural areas of Utah. Of the 41 districts and USDB, 14 enroll more than 10,000 students, 13 enroll from 2,500 to 9,999 students, and 15 enroll less than 2, 500 students.

Utah School Superintendents Association (USSA) Bylaws

Revised and Adopted April 2017

Purpose

The Utah School Superintendents Association (USSA) has the following purpose:

- To be an advocate for children and public education
- To discuss current and growing concerns in public education and provide leadership on statewide educational matters
- To provide in-service and professional growth opportunities to members
- To cooperate with other educational groups and administrative organizations to maximize influence and for professional development

Membership

Institutional membership is open to all forty-one Utah public school districts, the School for the Deaf and Blind, the Utah State Office of Education, and the Regional Education Service Agencies. Local district superintendents, the Utah State Superintendent of Public Instruction and the Superintendent of Schools for the Deaf and Blind shall serve as the Institutional Representatives for their respective institutions, with one vote each. Another person designated by the Institutional Representative may represent the institution at a meeting which the Superintendent is unable to attend. Other educators may attend Association meetings by invitation of a member or as warranted by agenda items. Utah Regional Service Agencies Directors fully participate in the association but are non-voting members.

Dues

The dues shall be set annually by the Executive Committee and shall be payable July 1st of each year.

Meetings

- **Monthly Meetings** - The regular monthly meetings of the Association will normally be held on the first Monday of every month, unless changed and announced in advance by the Executive Committee or by the President.
- **March/April Legislative Debriefing** - Each March/April following the end of the Utah Legislative Session, the Association membership shall meet to discuss resulting bills and financial information. This meeting will be scheduled annually by the Executive Committee and convened in St. George, Utah.
- **Summer (June) Conference** - The dates for the three-day annual summer conference shall be selected by the Executive Committee, and generally, will be held the third week of June. Notice of the date and location of the annual summer conference shall be determined and communicated to all members by April 1st of each year.
- **July Professional Development Conference** - A two-day professional development conference will be held each year, as approved by the Executive Committee, in July. It will be convened in alternating locations in the northern and southern parts of the State.

Legislative Priorities

Annual legislative priorities will be adopted by the Delegate Assembly, with development by the Association, in coordination with the Utah School Boards Association and the Utah Association of School Business Officials in a Joint Legislative Committee. In addition, the Association shall work toward reaching mutual goals with the Utah State Board of Education and other educational organizations.

Meeting Agenda and Quorum

No less than ten days before a regularly scheduled monthly meeting, the Executive Committee shall meet and establish an agenda to be sent to members. Anyone desiring to have an item considered for inclusion on the agenda should contact a member of the Executive Committee or Executive Director who will contact a member of the Executive Committee. The Executive Committee reserves the right to add late or emergency items to the agenda as needed. For purposes of conducting official business, a quorum is required, and is defined as a majority of Association members.

Officers

The Association officers shall consist of President, First Vice President, Second Vice President, and the Past President. The Second Vice President shall advance through the officer positions to eventually become President and Past President of the Association.

Nominations for office and elections to fill expired terms shall be held in May. Nominations will come from the group of districts involved (in a three-year rotation) but will be voted on by all members. Each year, a Second Vice President shall be elected from one of the three groups of school districts: Group I (Large), Group II (Medium), and Group III (Small) in rotation. The three groups of school districts include the following members:

Based upon retirements, movement to a district of the other group, change of assignments, and/or resignations of USSA officers, the Executive Committee may alternate the schedule of the three district groups in order to keep a fair balance of rotation as necessary. Appointments to a vacated position will be made by the Executive Committee as the vacancy occurs with the appointee occupying the position until the next election.

Executive Committee

The Executive Committee shall be composed of the officers of the Association, the State Superintendent of Public Instruction and the Executive Director of the Association. The State Superintendent and Executive Director serve as ex-officio members of the Executive Committee.

Committees

The Association shall have standing committees, as determined and appointed by the Executive Committee. Membership on these committees shall be assigned annually by the Executive Committee and announced at the Annual Summer Conference. These shall include, as a minimum, the Legislative Committee, chaired by the President or his/her designee; and the State Policies, Rules and Guidelines Committee, and chaired by the State Superintendent or his/her designee. The Executive Committee may establish other standing and ad hoc committees as needed. The Executive Committee approves participation by a member of the Executive Committee in other educational groups, including participation by the Executive Director.

Executive Director

The Executive Director of the Utah School Superintendents Association shall serve under the direction of the President to execute policies of the Association and perform other duties assigned by the President or Executive Committee. The Executive Committee will provide him/her with a written job description.

Amendments to the Bylaws

USSA bylaws may be amended by a vote of two-thirds of all Association members at any regularly called and duly constituted meeting of the Association, or by mail ballot.

The membership shall be given a copy of any proposed amendment prior to any vote on the proposal. Generally, the amendment will be proposed and discussed in one Association meeting and then voted on not less than thirty days later at a subsequent Association meeting. An amendment may be proposed or voted on by mail.

Superintendent of the Year

The Executive Committee shall determine the nominating and selection process for naming an annual Utah Superintendent of the Year and the selection process shall be the work of the Association's Past President each year. Generally:

- Nominations will be solicited in June
- Voting by membership will occur prior to August 1
- The award shall be announced each September ahead of the year of recognition

State Leadership and Resources

The Utah State Board of Education - The Utah State Board of Education (USBE) is comprised of 15 board members representing areas of the State of Utah. The Board sets general policies and oversight practices for all public schools in the state, traditional and charter schools. In addition, the State Board has direct board oversight for the Utah School for the Deaf and Blind.

The Utah State Office of Education - The Utah State Office of Education employs over 200 educators and staff members who serve the State Board of Education in their leadership and regulatory duties. The office has a strong curriculum staff, devoted, among other duties, to providing professional development, as well as leading legislative and State Board programs.

The USBE can be an effective partner with USSA in providing strong support and leadership for achievement goals. Individual USBE employees may be helpful as resources to superintendents.

Our Primary Goal and Purpose:

To increase effective and efficient student learning.

Our Challenge:

To increase investments in public education, build trust with lawmakers, and establish consistent policies, practices, and accountability measures.

Our Strategies:

To prepare each student for college, career, and civic success by:

- Fully funding all new students (growth)
- Acquiring adequate and flexible funding (WPU) for compensation, URS obligations, and insurance increases
- Attracting and retaining quality educators
- Supporting great teachers and leaders through professional development, professional learning communities, and meaningful evaluations
- Articulating high expectations for all students through standards-based instruction, appropriate assessments, and effective instruction
- Enhancing accountability and transparency through an appropriate balance of consistency (laws and policies) and flexibility (local control)
- Increasing stakeholder (i.e., parents, elected officials, community leaders, etc.) engagement

Key Elements Needed for Student Success in Schools

1. Long-term plan and commitment with adequate resources (high performing countries, states, districts, schools, classrooms)
2. World class standards with local control and collaboration (whole student focused, standards-based, data driven instruction)
3. Strategic investments for students, families and teachers (targeted

- professional development, PreK-3, STEM/STEAM, technology, interventions)
4. Effective teachers, leaders, and support staff (recruiting, retaining, mentoring, coaching, evaluating)
 5. Inclusion of all stakeholders in the process (professional learning communities, School Community Councils, and parents/community/agency/business partnerships)
 6. Authentic and prescriptive assessments, with local control, adequate resources, and time to implement (USSA, 2013)

USBA/USSA Policy Services

USBA provides a policy service available to members as they craft local policies around state law. USBA provides model policies which are reviewed by USBA's legal counsel (Burbidge & White, LLC.) for complete compliance to Utah Statutory and Administrative codes. Among other benefits the subscription service includes policy consultation via telephone, email, or in person; timely and informative legal memoranda; board training; and annual policy conference.

American Association of School Administrators (AASA)

The American Association of School Administrators advocates for the highest quality public education for all students and develops and supports school system leaders. Utah district superintendents are invited to join AASA annually.

AASA was founded in 1865 and is the professional organization for more than 13,000 educational leaders in the United States and throughout the world. AASA members range from chief executive officers, superintendents, and senior level school administrators to cabinet members, professors, and aspiring school system leaders.

AASA members are the chief education advocates for children. They advance the goals of public education and champion children's causes in their districts and nationwide. As school system leaders, AASA members set the pace for academic achievement. They help shape policy, oversee its implementation, and represent school districts to the public at large.

AASA believes it is time to get back to the basics of supporting the whole child – from physical and mental health to the development of fundamental, lifelong learning skills. Only when children have support for all their needs will schools have a real chance of helping every student master required education concepts and skills.

AASA's Statement of Ethics for Educational Leaders

An educational leader's professional conduct must conform to an ethical code of behavior, and the code must set high standards for all educational leaders. The educational leader provides professional leadership across the district and across the community. This responsibility requires the leader to maintain standards of exemplary professional conduct while recognizing that his or her actions will be viewed and appraised by the community, professional associates, and students.

The educational leader acknowledges that he or she serves the schools and community by providing equal educational opportunities to each and every child. The work of the leader must emphasize accountability and results, increased student achievement, and high expectations for each and every student.

To these ends, the educational leader subscribes to the following statements of standards.

The educational leader:

1. Makes the education and well-being of students the fundamental value of all decision-making.
2. Fulfills all professional duties with honesty and integrity and always acts in a trustworthy and responsible manner.
3. Supports the principle of due process and protects the civil and human rights of all individuals.
4. Implements local, state and federal laws.
5. Advises the school board and implements the board's policies and administrative rules and regulations.
6. Pursues appropriate measures to correct those law, policies, and regulations that are not consistent with sound educational goals or that are not in the best interest of children.
7. Avoids using his/her position for personal gain through political, social, religious, economic, or other influences.
8. Accepts academic degrees or professional certification only from accredited institutions.
9. Maintains the standards and seeks to improve the effectiveness of the profession through research and continuing professional development.
10. Honors all contracts until fulfillment, release or dissolution mutually agreed upon by all parties.
11. Accepts responsibility and accountability for one's own actions and behaviors.
12. Commits to serving others above self.
