



#### SALARY & BENEFITS

The compensation package will be competitive for the size of the school district in Utah and will be determined by professional preparation and successful experience in educational administration, as well as qualifications.

In compliance with Utah law, superintendents receive a two-year renewable contract.



#### BASIC POSITION REQUIREMENTS

- 1. A master's degree is required. Additional education or experience is preferred.
- 2. A successful record of administrative experience and accomplishment is required.
- Applicants must have substantial experience as a leader of a sizable organization. Leadership in a K-12 school system is preferred.
